# WHAT IS LOBBYING AND WHAT IS CIJA



- **Lobbying** is the process through which individuals and groups articulate their interests to federal, provincial or municipal governments to influence public policy or government decision-making
- The Centre for Israel and Jewish Affairs (CIJA) is the Zionist Israeli Lobby operating in Canada since Yr 2004. It also operates Canadian Jewish Political Affairs Committee (CJPAC) which also influences Canadian media and politicians .
  - The Zionist Israeli lobby has grown stronger over the years with massive influx of funds and has gained broader political influence in Canada.
  - Meanwhile in 2009 Conservative Minister Jason Kenney (based on massive campaign by CIJA/B'naiBrith) removed federal funding for Canadian Arab Federation (CAF), the Arab/Muslim lobby and settlement support group that was established in Canada in 1967

# HOW DOES CANADA SUPPORT THE ZIONIST STATE OF ISRAEL – PART I

---

- **CANADIAN ZIONIST CHARITIES** - There are 200+ Zionist charities in Canada that directly fund Israeli military and other illegal entities in Israel that are in violation of international law. Canadian tax payers are subsidizing these illegal money transfers for decades. Over \$1.3 billion in Canadian donations were sent to Israel in the last five years, to a country with GDP per capita equivalent to Canada.
  - Canadian Federal (Liberal) and Provincial (Conservative) governments have been ignoring calls for scrutiny towards these so called “charities”. These organizations under guidance from CIJA move money through a web of different charities in Canada just like a money laundering network.
  - **Examples:**
    - **UNITED JEWISH APPEAL OF GREATER TORONTO** (Registration# 119276723RR0001)
      - Funds raised - \$224 million in 2024
    - **GERALD SCHWARTZ & HEATHER REISMAN FOUNDATION** (Registration# 138445580 RR 0001 )
      - Funds raised – \$85 million in 2023

# HOW DOES CANADA SUPPORT THE ZIONIST STATE OF ISRAEL

## – PART 2

- **TOLERANCE/SUPPORT FOR ANTI-MUSLIM/ANTI PALESTINIANIAN ORGANIZATIONS**
  - **B'NAI BRITH NATIONAL ORGANIZATION OF CANADA (Registration# 787557495)**
    - Zionist Organizations like B'Nai Brith that operate under CIJA actively pursue/target Muslim and pro Palestinian organizations in Canada while operating as a Canadian charity
- **INSTITUTIONAL BIAS AGAINST MUSLIM CANADIAN CHARITIES**
  - Review and Analysis Division under CRA (which has been operating under the Conservative & Liberal governments) actively targets Muslim Charities in Canada. See link <https://www.layeredsuspicion.ca/>
- **CANADIAN POLICE DEPARTMENTS CONNECTIONS WITH ISRAEL**
  - Israel is involved in Canadian prison systems, involved in training the Royal Canadian Mounted Police and also involved in our airport security.

# How Does Canada Support the Zionist State of Israel – Part 3

---

- **MILITARY EXPORTS** – Canada exported more weapons to Israel in year 2023 (under Liberal government) than in any other year on record. This is also during a period in which Israel stands accused of genocide against Palestinians. See list of 57+ weapon companies in Canada actively involved in arming the Israeli military.
- **PENSION PLAN INVESTMENTS** - The Canada Pension Plan Investment Board (CPPIB) invests over a quarter-million dollars in companies deemed by the UN to be in violation of international law. Ontario Teachers Pension Plan funds are also invested in weapons manufacturers who directly contribute to and profit from Israel's genocide and apartheid.
- **CANADA ISRAEL FREE TRADE AGREEMENT (CIFTA)** – 'Annexing Palestine Through Trade' is a good CJPME article to read to better understand this Free Trade Agreement and how its hurting Palestinians.

# How DOES CANADA SUPPORT THE ZIONIST STATE OF ISRAEL - PART 4

---

- **CANADIAN UNIVERSITIES:** Leading Canadian Universities (like University of Toronto, York University, Queens, McGill etc.) have invested student tuition money in companies and / or funds implicated in supporting Israeli apartheid and genocide. [See link for more information](#)
- **SALE OF STOLEN PALESTINIAN LAND IN CANADA:** Zionist Israeli organizations not only steal Palestinian land/homes and displace Palestinians but also openly sell these stolen lands here in Canada (exclusively to Zionist settlers). These illegal real estate events (led by [Keller Williams realty](#)) are scheduled in Canada regularly under police protection. [See link for more information](#)
- **ISRAEL BONDS:** Canada allows purchase of [Israel Bonds for Canadians to invest in Israeli Apartheid and Genocide](#). Purchase of these questionable bonds are somehow even eligible for Canadian RRSP, RESP and TFSA investments.

- Summary of CIJA sponsored propaganda trips for Canadian MPs to Israel (since 2007). Attempts to corrupt Canadian politicians via lavish fully paid vacations.

- CIJA is also circumventing new rules aimed at stopping these sponsored trips

- **Stephen Harper** – 22<sup>nd</sup> Prime Minister of Canada who is currently the Partner and President of AWZ Ventures. This firm invests in Israeli cybersecurity, intelligence and physical security technologies.
- **Shimon Fogel** , outgoing CEO of CIJA
- **Noah Shack**, current CEO of CIJA
- **Anthony Housefather**, Liberal MP and a proud Zionist. Special Advisor on Jewish Community Relations and Antisemitism
- **Irwin Cotlier**, Ex-Antisemitism envoy
- **Gerald Schwartz** (Onex Corp) and **Heather Reisman** (Indigo Books), Original founders of CIJA
- **David Weinberg**, runs Israel's office at CIJA
- Activities/meetings/discussions of the above key players must be closely monitored to understand which current/upcoming politicians are being influenced by the Zionist Lobby.

## SUMMARY

- Our short term / long term voting strategy must be based on full knowledge of Zionist Lobby's current reach and influence.
